DUPLI-COLOR Sealer is quick-drying, externely low-wear, friction-free and non-yellowing. The sealer is excellently suitable for wood and wood-simalar objects like parquet floor, timber stairs, tables, chairs etc.

 Drying time (at 20°C, 65% relative air humidity):

Coatable: after 12 hours Walk-on-able: after 24 hours

The drying time depends on surrounding temperature, air humidity and absorpitivity of the wooden ground.

- Best working temperature and object temperature: 10 - 25°C
- Cleaning of tools: immediately after use with a synthetic thinner

Storage stability:

5 years if appropriate storage provided (=10°-25°C, relative air humidity of max. 60%) in the unopened original container. Do not store below 5°C

Size: metal tins 250 ml and 750 ml

Environment and labelling

Environmentally compatible: European Aerosols is committed to apply formulations without restricted or critical ingredients and to achieve best possible performance. The caps and packagings are made of recyclable material.

Disposal: Please mind the residue inside the containers. Completely emptied containers can be used for recycling. If cans are not emptied, they should be disposed off as "special refuse".

Before use, carefully read and observe the warning texts on the label!

Preparation of the ground:

The surface has to be bearing, dry, clean and free from fat and rust.

Painting:

- 2 paint coats in 4 hours intervals.
- . Between the coats we recommend to sand with a fine grain.
- Can be diluted with max. 5 % synthetic thinner.
